 Interview Summary I'm the Manager at Rite Aid. A B/M came in around 10:15am. He asked me for band aids. I asked if I could help him. He said eh w as n't sure what he wanted and had to ask his girlfriend. He said he'd be back. He left. He went down the end of the street and made a right. He had black pants, dark brown sweat hoody past his waist, 25-29 yrs old, facial stubble, white B/B cap w/brown designs. Then he came back I was in the 2nd aisle. He walked up to me but had a sarf pulled p to his nose. He walked upto me with a scarf pulled up to his nose. He had something in his hands. It looked like he had a gun in his pockets. He said, "Put your hands up and go back to the pharmacy. He yelled at the pharmacist to give him all the narcotics. He knew what he wanted. He said percocets. When I was at the pharmacy, I saw metal, something square it was something chrome out of his sweatshirt. Before I went back, he grabbed my cell phone out of it's case. He told me to lay down with the pharmacist. Then he said to stay on the floor and don't move repeatedly.
